Apply the product on the surface possibly with a Microfiber cloth Extraklin or with a paper. Let act for 5 minutes to obtain a bactericide action and 15 minutes for an action against fungus and viruses, according to the following norms: UNI-EN 1276; UNI-EN 13697; UNI-EN 1650; UNI-EN 14476.

Spread evenly and let dry.

SANIDART is active for gram negative and grams positive, bacteria, for Pseudomonas and Candida Albicans and for the main

types of virus also the ones with envelope like the Corona virus.
