


STABIREK SUPER C

CHLORINE STABLE SUPERCONCENTRATED DETERGENT DEGREASER



GENERAL DESCRIPTION

Detergent degreaser super concentrated to be used with dosing systems to prepare STABIREK at standard concentration or to make the ready to use washing solutions.

This product is particularly formulated for floors and for equipments, furniture, walls in medical environment in combination with the chloroactive disinfectant tablet BIOSPOT for a combined detergent disinfectant action. The solution of **STABIREK FANTASY SUPER C** at 0,5% - 1% with 2 Chlorine tablets of 3,25 g of BIOSPOT for 10 liters of solution (equivalent to 200 ppm of available Chlorine) maintains the original chlorine level for 2 days after the preparation.

DIRECTIONS FOR USE

Hand dilutions:

Dilute one part of product with 4 parts of water to make the standard STABIREK. Dilute that product at 2.5 or 5% (for very dirty surfaces).

Dosakem systems:

Use with the yellow Venturi with grey tip or the grey Venturi with beige tip to prepare STABIREK at standard concentration. Dilute that product at 2,5% or 5% (for very dirty surfaces).

To prepare the ready to use solutions from **STABIREK FANTASY SUPER C** use the yellow Venturi with the violet tip (0,5%) or yellow tip (1%).

1 liter dosing bottle:

Unscrew the cap and squeeze the bottle to fill the dosing chamber up to the desired volume.

Use 2-4 doses of 30 ml for 12 liters of water.

30 ml dosing pump:

Screw the pump on the 5 liters canister and use 2-4 doses for 12 liters of water.
